說明：104年5月20日修正公布之公務員懲戒法，自105年5月2日施行。為因應現制，懲戒處分新增「免除職務」、「剝奪、減少退休(職、伍)金」及「罰款」，爰將「地方最高行政長官」修正為「省、直轄市、縣(市)行政首長」。

Note: The amended Public Functionary Disciplinary Sanction Act was promulgated on May 20, 2015 and entered into force on May 2, 2016. In compliance with the current system, "removed from office," "deprivation or reduction of pension" and "fine" were added in the disciplinary sanctions. In addition, "local supreme administrative officer" was revised as "chief administrative officers of Province, Municipalities, Counties (Cities)."
