Note: 1. Public Functionary Disciplinary Sanction Commission had reformed into Disciplinary Court on July 17, 2020. The Disciplinary Chamber of the Judiciary, which had been affiliated to the Judicial Yuan, became a branch of Disciplinary Court and altered its court system from "one-level and one-instance" to "one-level and two-instance".

2. The Disciplinary Chamber of the Judiciary, which originally affiliated to the Judicial Yuan, has become a branch of the Disciplinary Court. And its pending cases are listed under the category of the Disciplinary Court.
