說明：1. 公務員懲戒委員會自 109 年 7 月 17 日起改制為懲戒法院，下設懲戒法庭及職務法庭分別審理公務員懲戒案件、法官及檢察官懲戒案件、職務案件，且採一級二審制。

2. 職務法庭原本隸屬於司法院項下，自 109 年 7 月 17 日未結案件移至懲戒法院辦理。

Note: 1. The Public Functionary Disciplinary Sanction Commission had reformed into Disciplinary Court on July 17, 2020, setting up two branches: the Disciplinary Chamber in charge of the disciplinary sanction cases of civil servants, and another is the Disciplinary Chamber of the Judiciary that is responsible for both of the disciplinary sanction and judicial discipline cases of judges and prosecutors. Also, the court has adopted the "one-level and two-instance" court system.

2. The Disciplinary Chamber of the Judiciary, which originally affiliated to the Judicial Yuan, has become a branch of the Disciplinary Court. And its pending cases are listed under the category of the Disciplinary Court.
