Description: The amended Public Functionary Disciplinary Sanction Act was promulgated on May 20, 2015 and entered into force on May 2, 2016. In compliance with the amendments, the term "re-deliberation cases" was revised as "retrial cases." "Removed from office," "deprivation or reduction of pension" and "fine" were added in the disciplinary sanctions.
