Notice	<ol> <li>Where a party may not appear before the court, he/she may designate an agent ad litem who may be a lawyer provided in accordance with Article 49 of Administrative Litigation Act or a person with qualifications provided in Paragraph 2, Article 49 of the same Act. The agent ad litem shall bring the power of attorney and identification to the court.</li> <li>If one party fails to appear in the oral-argument session without justification, the court may enter a default judgment based on the submission of the appearing party. When both parties fail to appear in the oral-argument session without justification, unless it is an action against public welfare, the complaint will be deemed as withdrawing his/her case in consent. In the instance that the litigation is not continued within 4 months or when the court deems it necessary to continue the litigation on its own initiative while both parties fail to appear in court, the litigation will be deemed as withdrawn. For litigations concerning public welfare, the court may investigate the facts of the contention on its own initiative and enter a judgment without oral argument when both parties still fail to appear in the oral-argument session.</li> <li>When the person notified appears incourt, he/she should report to the court attendant with his/her ID and this notice.</li> <li>If needed, you may consult with lawyers or apply for legal aid to a branch of the Legal Aid Foundation to protect your rights.</li> </ol>							

- 5. If the person notified wishes to produce any document, the case number and the summary of case must be shown on the document. Documents may be provided via e-mail. The email address for administrative litigation documents is: OOO@judicial.gov.tw.
- 6. A witness who fails to appear in court without justification, the court may impose a penalty and/or take the witness into custody under Article 143 of the Administrative Litigation Act. When a witness arrives at the court by himself/herself, he/she may request the daily and travel expenses stipulated by the law after the interrogation. An expert witness may request the daily and travel expenses stipulated by the law, together with appropriate compensations.
